Any person, corporation, partnership, or limited liability company which transacts any temporary business in North Dakota and does not intend to become a permanent merchant of the place where business is transacted is a transient merchant and must obtain a transient merchant license from the Office of Attorney General. Requirements for a license include a \$200 license fee and a bond of at least \$1,000 but no more than \$50,000 payable to the State of North Dakota. In addition, a transient merchant should also contact the city and county in which he or she will be transacting business because local jurisdictions may also require a local transient merchant license. A transient merchant who sells only livestock or agricultural products or who only sells at flea markets, craft fairs, fairs, carnivals, circuses, or similar activities regulated by local jurisdictions is not required to obtain a state transient merchant license.
